6. The bids will be opened in the presence of Bidders' representatives who choose to attend BS **2083/02/21 (4th June 2026) at 13:00 hours** at the office of **Rajdevi Municipality**. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of **as mentioned in above table**, which shall be valid for 30 days beyond the validity period of the bid.
